# Multiple Exclusion Homelessness – a Safeguarding tool for practitioners

This <u>3-stage toolkit</u> was developed with the aim to improve multi-agency support for individuals who appear to have care and support needs and are experiencing Multiple Exclusion Homelessness.

Research has shown that people experiencing Multiple Exclusion Homelessness are often overlooked by services and their care and support needs are not well recognised, leading to missed opportunities to do preventative work.

# **Right to choose: Spotting the signs of forced marriage**

A powerful video from the Foreign, Commonwealth and Development Office, raising awareness about dangers of <u>forced marriage</u> – remind young people to speak up if they think they or someone they are close to are in danger.

## Update from SAB Executive

The SAB Executive met in November 2023 and in January 2024. We had an update around the Advanced Customer Support service covering Safeguarding in DWP, discussed establishing a Task & Finish Group on interface with Wandsworth Prison and the wider Criminal Justice System, agreed to update the Information Sharing Agreement and have each member agency sign it, and noted report on the work of the sub-groups. The Executive discussed the Right Care Right Person and noted it was going well, although early days yet – it will remain on the agenda for monitoring. The Local Authority will keep CQC Inspection as a standing item, to update on any work around this, and the Head of Refugees Service gave an update on the forming of the team.

#### **Quality and Improvement Sub-group**



The Quality and Improvement Sub-group met in January 2024. It discussed an update on actions assigned to the subgroup in the Business Plan

2023/24. We had a good long discussion and update around homelessness and rough sleeping, including safeguarding concerns raised on people with no fixed abode. The sub-group discussed updates around training compliance from partners at future meetings, reviewed the Dashboard for Q3 and heard updates on safeguarding cases around sexual abuse, as well as an audit of concerns which did not progress to enquiries.

## Safeguarding Adult Review (SAR) Sub-group

The SAR Sub-group met in December 2023 and January 2024. It discussed updates on Regulation 28 reports concerning partners in

Richmond or Wandsworth, and Learning from other reviews (DHRs, Children Reviews and SARs from other neighbouring Boroughs). There were no new referrals.

## **Richmond and Wandsworth Community Forums**
