## **MCA Executive Functioning**

Detecting executive impairment and assessing the effect on mental capacity can be very challenging This helpful guidance on <u>Mental Capacity Act Executive Functioning</u>, developed by colleagues in Blackpool and Lancashire, aims to increase the practitioner's awareness and detection of these issues, so that more specialist advice and support can be sought if required.

# Fire Safety E-Learning



A toolkit developed by Sutton and generously freely available to all, it aims to equip all those who come into contact with people who are at increased risk of fire in their homes with the knowledge and understanding they need to help prevent fatal or serious fire incidents. It contains a <u>free e-learning course</u> on fire prevention and safeguarding which draws on the 8 key principles from the most common themes identified in serious adults and children safeguarding reviews. The principles are introduced through a <u>video clip</u>.

The fire prevention guidance focusses on environmental factors, and lifestyle and behavioural factors to then explore the specific health and social care needs to take a person-centred approach to keep people safe from harm by fire.

# **Share for Better Care Week**



# Share for Better Care Week is a week where people are encouraged to have a stronger voice in their care.

It runs from 24<sup>th</sup> February to 2<sup>nd</sup> March, and it is all about encouraging people to leave feedback about their care good or bad. It is run by Healthwatch and CQC.

Feedback about health and social care matters. It helps services spot and identify what's working well, and areas for improvement. However, 60% of people have never given feedback on care, and not everyone's voice is being heard. We want that to change. This week, encourage people to spend a few minutes giving feedback about their care.

We know people have busy lives, but if they take a few minutes to give feedback and share their experiences while waiting for a kettle to boil, or for a bus, they can make a huge difference to the lives of others.

- Neurodiversity and Dementia


