## **RWSAB Safeguarding Adults Practice Awards**

Dave Nwokedi, a Service Manager in Richmond and Wandsworth Council, was nominated in recognition for his involvement with chairing S42 meetings, ability to keep the adult at risk at the centre of the safeguarding process and to manage meetings in a way which focuses on the matters which need discussion. Dave always ensures that explanation is given to relatives and service users on why meetings are held while at the same time managing their expectations well. This makes service users and relatives feel listened to and part of the decision-making process.



**Dave Nwokedi said:** I am happy to accept this award for my recognition of putting services users and their families at the heart of what makes for good safeguarding practice. As they say, it takes a community to raise a child, so the same applies with good practice; I am where I am today due the many who have gone before me and walked alongside me in showing what good practice looks like. I came into this work to serve those I come into contact with and always strive to keep those who are in need of our support at the

centre of all that we do.

## **Wandsworth Level of Need Guidance to Multi-Agency Partners**

The new Levels of Need Guidance replaces the previous Threshold Guidance which should be removed from use. We have undertaken the change to better focus upon children's needs and to replace language about barriers that thresholds imply. The new framework focusses upon the needs of children within a family or community context and we have included new references to the impact of discrimination.

The purpose of the Levels of Need Framework is unchanged. It provides guidance and is intended to support the partnership in discussion about the needs of children and how services can support children and families **get the right help at the right time**. It contains updated advice on consent and professional judgement. Each child, family and extra-familial context will have a unique set of needs and strengths. The Levels of Need Framework is a guide and is not intended to replace creativity, curiosity, knowledge, experience, and discretion.

We would invite you to share widely with staff and to use the framework when thinking about how best to support and safeguard children; it can support discussion, decision making, supervision and reflection in your organisations

Guidance on the Levels of Need for children and young people at risk outside of the home (contextually) is also included, to reflect the changing needs and vulnerabilities of children and to provide support to partners in this complex area of safeguarding.

#### **Trauma Informed Practice Training**

Please find below dates for this one-day (done in two half-days) interactive workshop for Partner Agency Staff to support the development of trauma-informed practice through increasing understanding of the prevalence, presentations and impacts of trauma, increasing understanding of trauma-informed approaches and exploring their application in practice.

#### **Training objectives**

To support the development of trauma-informed practice through increasing understanding of the prevalence, presentations and impacts of trauma, increasing understanding of trauma-informed approaches and exploring their application in practice.

#### **Learning outcomes**

In this interactive workshop participants will:

- Describe how to identify trauma
- Identify protective and risk factors
- Explain attachment theory and the trauma cycle
- Explain possible behavioural / psychological responses to trauma such as Personality Disorder, Eating Disorder, Promiscuity, Substance use etc
- Describe practical strategies for dealing with trauma including building trust, survivor partnerships, psychosocial therapies and medication

## **Update from SAB Executive**

The SAB Executive met on 27 September 2022. Public Health provided an update on the work with Wandsworth Prison around suicide prevention. The group discussed the HMIC Police Report, workforce pressures, LA Care Act Compliance around CQC inspection and signed off the Annual Report. The Executive heard updates from the sub-groups and discussed the budget and the risk log.

## Performance and Workforce Subgroup



The Performance and Workforce Sub-group will met on 12 September 2022. It had a presentation from CQC on the quality of provision of Care and

Health services in both Richmond and Wandsworth, which is very good. The Sub-group agreed proposal for the SAB Executive on the Annual Self-assessment questionnaire, which will be sent out in November 2022 for completion by first week of January 2023.

# Safeguarding Adult Review (SAR) Sub-group



The Sub-group met on 05 September 2022. There was one new referral, which did not meet criteria for a SAR. The Action plans from completed

SARs are monitored and progressing, with 96% completed actions from 11 SARs.

## **Communication and Engagement Sub-group**



The Richmond Community Forum met on 22 June 2022. The Forum members discussed updates from partners, in particular around recent scams, and agreed how to share information more widely. Members found it very good to receive and review the Performance data of Safeguarding across the borough and highlight areas of concern to all organisations. It was agreed that this will be a standing

agenda item for sharing and discussion going forward. Colleagues from Community Safety gave a presentation around Violence against Women and Girls, highlighting available domestic abuse support services in Richmond, the types of domestic abuse support services through Hestia available from 21<sup>st</sup> November and noting the work of the Multi-Agency Risk Assessment Conference (MARAC). Wandsworth Community Forum met on 19 October 2022 and heard updates from partners around safeguarding. A Wandsworth GP gave an update around Public Access to Care records, the group discussed the Performance Dashboard and Impact of the Cost-of-Living Crisis on safeguarding and information for residents.
